

Elizabeth Miller PRO11/1855

This is the last Will and Testament of me **Elizabeth Miller** of Peterborough in the County of Northampton Spinster. First I will and direct that all my just debts funeral expenses and the charges of proving this my Will be paid and discharged by my Executors hereinafter named. I give and bequeath to **John Youd** of Fletton in the County of Huntingdon, Gentleman the sum of ten pounds of lawful money of Great Britain. Also I give and bequeath unto the two children of my cousin **Elizabeth Woolley** the Widow of William Woolley late of Market Deeping in the County of Lincoln deceased the sum of Twenty pounds of like lawful money to be equally divided between them share and share alike. Also I give and bequeath unto **Mary Stevens** the daughter of Samuel Stevens of Peterborough aforesaid Currier the sum of one Guinea and my Gold Ring marked with the letters RM. Also I give and bequeath unto **Mrs Crisp** the wife of William Crisp the younger of Peterborough aforesaid Currier my Gold ring in which is my late mothers hair. Also I give and bequeath unto **Nelson Wilkinson** of Peterborough aforesaid Gentleman the sum of Ten pounds also my best Broach silver knife and Locket with my Late Father's Hair in it. Also I give and bequeath unto **Mary Buckle** the Widow of William Buckle of Peterborough aforesaid Common Brewer the sum of Ten pounds. Also I give and bequeath unto my General Maid **Ann Rimmington** who now lives with me the sum of Thirty pounds and my wearing apparel all which said bequests and legacies I will and direct shall be paid and delivered to the said several and respective Legatees within six months next after my decease. And as to all the rest residue and remainder of my monies and securities for money household goods furniture plate linen china and all my personal Estate and Effects whatsoever and wheresoever and of what sort nature or kind several the same shall or may be or consist at the time of my decease and not hereinbefore by me otherwise disposed of I give and bequeath the same and every part thereof unto the said **Nelson Wilkinson** and **William Crisp** of Peterborough aforesaid Draper to and for their own use and benefit equally to be divided between them share and share alike. And I do hereby nominate constitute and appoint the said **Nelson Wilkinson, William Crisp, Ann Youd** of Market Deeping in the County of Lincoln Widow Executors of my will and hereby revoking and making void all former and other wills by me at any time heretobefore made. I do declare this to be my last Wills and testament In Witness whereof I have to this my last will and testament set my hand and seal this twenty fourth day of July One thousand eight hundred and thirty three The mark of Elizabeth Miller Signed sealed published and declared by the testatrix Elizabeth Miller as and for her last will and testament in the presence of us who in her presence at her request and in the presence of each other have hereunto subscribed our names as witnesses
