This is the last Will and Testament of me Tamberlain Gwillim of New Sleaford in the County of Lincoln Esquire made and published in manner following that is to say I give to Mrs Sarah Jones the sum of one hundred pounds which I charge on my Personal Estate herein after bequeathed to my Relations to be paid by them at the end of one month after the decease of the persons who are and will be intitled to life Estates therein I give and devise unto John Brittain of New Sleaford aforesaid Gentleman All that the reversion upon the decease of my Mother Ann the Wife of the said John Brittain of and in all those messuages lands tenements and hereditaments situate and being in the County of Hereford and all and singular other the real Estate of what nature or Kind soever to which I am entitled to on the death of my said Mother and have power to dispose of To hold the same(subject nevertheless to the life Estate therein of my said Mother) unto the said John Brittain and his assigns during the term of his natural life and from and after his decease I give and devise the reversion of and in the same hereditaments and premises unto and equally between all and every the child and children of my Cousins Elizabeth the Wife of Edward Hans Lechmere Esquire and all and every the child and children of my Cousin John Jones Clerk To hold the same to them respectively their heirs and assigns for ever as tenants in common and not as joint tenants and to the survivors of them as may be living at the time of my death And Whereas after the decease of my Mother Ann Brittain I am intitled to two thousand five hundred pounds three per cent consolidated Bank annuities I do give and bequeath the said Bank stock in manner following that is to say To John Cubley William Cubley and Tamberaline Cubley the sum of five hundred pounds each and in the event of either of their deaths before the same becomes payable I give the share of him so dying to the survivor of them To my Cousins Richard Bulliman son of the late Ralph Bulliman two hundred pounds and to ffrederick Bulliamn Ann the Wife of Thomas Redhead Rebecca Bulliman Thomas Bulliman and James Bulliman son of the late Richard Bulliman the sum of one hundred pounds each and if it should happen that any of them the said Ricahrd Bulliman ffrederick Bulliman Ann Redhead Rebecca Bulliman Thomas Bulliman or James Bulliman shall depart this life in the lifetime of my said Mother and before their share in the said Stock can be transferred without leaving lawful issue of his her or their body or bodies Then I hereby the share or shares of him her or them so dying unto and equally between the survivors of them in equal shares and proportions I give all rent and arrears of rent that may be owing from my Estate at my decease and all other my monies and effects unto Mrs Elizabeth Lechmere my Executors first paying thereout my funeral and testamentary expences and the legacies hereinafter given And I do hereby nominate constitute and appoint the Reverend Richard Yerburgh of New Sleaford aforesaid D.D. Edmund Pateshalt of Allensmere in the said County of Hereford and William fforbes of New Sleaford aforesaid Gentlemen joint Executors of this my last Will and Testament And I do bequeath to them twenty pounds apiece for mourning rings And I do hereby revoke and make void all
